1) Education: OpenDoors of Asheville is a college completion organization that provides education consulting for up to 50 students who are growing up in persistent poverty with a focus on students in middle school through college graduation who are enrolled in public, charter, and private schools. OpenDoors provides access and referrals for tutoring, transportation, nutrition assistance, uniform assistance, psycho-educational testing, job placement, technology, and tuition and fees assistance. Services provided to students are highly individualized with the end goal being students prepared to enter and complete college with little to no student debt.

2) Enrichment: OpenDoors of Asheville provides STEAM focused programming that advances student academic achievement with programming outside the classroom. The program includes:
- Saturday Math Club: OpenDoors students meet weekly during the schools year in partnership with advanced math students from Asheville School, many of whom are African-American. In addition to improving their skills, OpenDoors students have role models for academic success and civic engagement.
- One Neighborhood Arts Program - Glass Blowing: In collaboration with North Carolina Glass Center, sessions are led by artists using a STEAM-based educational approach. Students learn the applied math, science, and business skills of a professional artist, and create works they will sell in the NC Glass Center gallery.

3) Advocacy - OpenDoors provides school-based advocacy in partnership with parents for students growing up in multigenerational poverty and not meeting their academic potential in school. Advocacy is individualized and based upon student needs and is directed by staff members with experience advocating for students within the school environment. Advocacy items included, but not limited to, full psycho-educational assessments, school choice, graduation and credit monitoring, suspensions, college readiness, and attendance at IEP and 504 planning and implementation meetings.
