To & Through College Access and Completion Initiative: OpenDoors employs a whole-child approach to help students reach their full potential. Working alongside parents and educators, we ensure our students have the stability, resource equity, and inclusion they need to thrive. By addressing family needs, reducing institutional barriers, and providing academic intervention, support, and enrichments, our students move To & Through college, becoming inspired members of our community who break the cycle of poverty for themselves, and generations to come. In 2020, we served eight college students and are excited to celebrate our first cohort of graduates in the Spring of 2021. The majority of our college student shave applied to or are planning to apply to graduate school to pursue Masters's degrees.  
OneNeighborhood STEAM Enrichments: Providing enrichment opportunities for our students continues to be essential for promoting student outcomes. Because of COVID-19 much student programming changed or halted, however OpenDoors was able to create two new summer programs designed for quarantine. We had our first "Out of the Box" summer challenge where students received activity boxes aimed at learning, creating, and reflecting to compete for prizes. We also coordinated a Summer Arts, Fun, Enrichment (S.A.F.E.!) program which included DJ classes, Hiking, Leadership, NC Glass Center arts, and more.  
When schools closed due to the pandemic, OpenDoors pivoted to establish a

Coaching & Consulting: OpenDoors works with students, parents, schools and other community partners to ensure that students attend a Best-Fit school for their unique academic needs. We serve as a nexus of support for students and families as they navigate milestones toward a post-secondary opportunity. We advocate with families, facilitate access to information, clarify processes, address implicit bias and inequities in schools and engage in conversations that lead to educational experiences that are responsive and help students realize their academic goals. In 2020, we reviewed all student's IEPs and met with school staff to insure adaquate supports were in place, intervening where they were not; provided equity-based coaching to community partners reaching over 70 participants; and oversaw multiple school tranfers to Best-Fit schools.
